INVITATION FOR EXPRESSION OF INTEREST BY CHARTERED ACCOUNTANTS

UGC-DAE Consortium for Scientific Research, Indore (UGC-DAE CSR) is an autonomous institution established by the UGC, New Delhi under Section 12 (ccc) of the University Grants Commission Act 1956 and registered as Society under M. P. Registrarian Adhiniyam 1973 with headquarters at Indore and Centers at Indore, Mumbai and Kolkata. The UGC-DAE CSR coordinates research from scientists/ teachers from all Indian Universities on major facilities like Dhruva Reactor, Variable Energy Cyclotron, INDUS-I etc. established by the Department of Atomic Energy, in addition, the Centers are also having many advanced research facilities. UGC-DAE CSR is fully funded by University Grants Commission (UGC). Other institutions also sanction specific and temporary scientific research projects from time to time. Financial transactions and Auditing of Financial accounts, Statement of Accounts and Certificate of Utilization of Grants are governed by Memorandum of Association & Rules, Bye-Laws & Service Conditions, General Financial Rules of Govt. of India, Orders of UGC and orders issued thereunder from time to time. There was expenses of Rs.4792 lakhs for year 2018-19, and there were sanctioned strength of 137 employees as on 31-March-2019. All the Centers of the UGC-DAE CSR maintain financial accounts for the concerned Centre separately, which are audited by the Chartered Accountants of the UGC-DAE CSR and are consolidated in the overall accounts of the UGC-DAE CSR.

UGC-DAE CSR seeks Expression of Interest from only those Chartered Accountants, who are acquainted with General Financial Rules of Govt. Of India, Orders thereunder which Consortium follows and are empaneled with CAG, for auditing of the financial accounts of all the three Centers and Head Office for year 2019-20. The Expression of Interest must contain acceptable audit fee and should be submitted in a sealed envelope along with detailed profile and list of names & addresses of the Central Government officers/ Central Autonomous Bodies/ Central Government institutions of which audit has been/is being done. Before submitting the sealed Expression of Interest interested Chartered Accountants may contact the undersigned for getting any other information found to be relevant.
