The UGC-DAE Consortium for Scientific Research (UGC-DAE CSR) is an autonomous institution established by the UGC, New Delhi with headquarters at Indore and Centers at Indore, Mumbai, Kolkata and Kalpakkam. This Consortium also has a Node at Institute of Physics (IoP), Bhubaneswar. Each Centre is headed by a Centre-Director. The UGC-DAE CSR coordinates research from scientists / teachers from all Indian Universities on major facilities like Dhruva reactor, Synchrotron, Cyclotron etc. established by the Department of Atomic Energy. In addition, the Centers are also having many advanced research facilities including in the areas of condensed matter physics or allied areas.

### General Instructions:-

1. The applicants must apply online at <https://csr.res.in/> on or before the last date and submit the printout of the application form along with self-attested copies of required documents to the following address:-

Institute will not be responsible for any postal delay or application lost in transit.
2. The applicants are required to pay a non-refundable **application fee of Rs.500/-** through SBI Collect and include the transaction ID/UTR number at the online application portal. Women candidates and candidates belonging to SC/ST/PWD communities are **not** required to pay any application fee.
3. Candidates are advised to fill their correct and active e-mail addresses in the online application as all correspondence will be made by the Institute through e-mail only.
4. The applicant must ensure his/her eligibility for the post in respect of Age, Qualification, Experience, Specialization, and other requisite criteria as prescribed and only then should apply.
5. All the details furnished in the online application will be treated as final and no changes shall be entertained. The responsibility of making correct entries in the application form lies with the applicant.
6. Institute strives to have a workforce, which reflects a gender balance; women candidates are therefore encouraged to apply.
7. The age limit and qualification/experience etc. for the post as on the last date of submission of online application form shall only be considered.
8. Canvassing in any form will be a disqualification.
9. No interim correspondence shall be entertained.
10. Selected candidate can be posted to any Centre or Node of the Consortium.
11. The positions reserved for specially abled persons (OH, VI, HH) for which the particulars post(s) has been reserved, the candidate of other categories of specially abled persons may also submit their application. In case of non-availability/suitability of the applicant of certain category of advertised post(s) may be filled up by the suitable applicant belongs to other categories of disabilities.
12. Persons employed in Government/Semi Government Organizations/Autonomous Bodies should forward their application through proper channel and submit a “No Objection Certificate (NOC)” with vigilance clearance from the present employer. If the candidate is unable to attach a NOC and a Vigilance Clearance due to shortage of time, they will have to provide an undertaking stating that the NOC and Vigilance Clearance from the present employer will be provided during the written test/ interview. They should also state in the undertaking that if they are unable to provide a NOC and Vigilance Clearance at the time of written test/ interview, their candidature will be rejected and application fee will not be refunded.
13. Fee once paid is non-refundable/ non-adjustable.
14. Age-relaxation as applicable to reserved category and candidates working in Govt./Semi. Govt./ Autonomous Body/ University will be as per GoI rules.
15. For any claim of Age Relaxation/ Reservation, the same is to be allowed only upon production/ submission of Certificate issued in prescribed Format under the relevant rules and notification latest (Not older than one year) by permitted authority with Seal as per applicable latest Government of India orders in this regard. All such claims are also liable for independent verification by the Institute at any time.
16. Applicants should include self-attested photocopies of marks sheets/certificates in support of all the qualifications and relevant experience with application. All Mark sheet, Certificates, Degrees, NOC and other documents must be produced in original at the time of Written Test/ Trade Test/ Skill Test/ Personal Interview as well as at the time of joining for verification. In case, it is found at any time in future, that during the process of selection or even after appointment the applicant was not eligible as per the prescribed RRs which could not be detected at the time of selection for whatever

reason, his/her candidature / appointment shall be liable to be cancelled / terminated immediately.

17. Only screened-in/shortlisted applicants will be called for Written Test/ Skill Test/ Trade Test/ Personal Interview.
18. Mere fulfilment of eligibility criteria does not confer any assurance for being called for the Written Test/ Skill Test/ Trade Test/ Personal Interview. The Institute reserves the right to restrict number of candidates to be called for the Interview by short-listing the applications on the basis of higher benchmark for short-listing criteria as may be decided by the Institute.
19. Institute reserves the right to reject or accept the candidature of any applicant for a valid reason. Institute reserves the right to cancel/restrict/enlarge/modify/alter the recruitment process, if need arises, without issuing any further notice or assigning any reason therefore.
20. The Number of posts shown above may change and may vary at the time of selection. The Institute reserves the right not to fill any/ all posts advertised and to reject any/all application without assigning any reason.
21. The applicants would be admitted to the Written Test/ Skill Test/ Trade Test/ Personal Interview on the basis of the information furnished by them in their application form. They are therefore advised to ensure that they fulfill all the eligibility conditions before applying. In case it is found at a later stage that the information furnished by an applicant is false or an applicant does not fulfill any other eligibility conditions, the candidature of such applicant would be cancelled and no correspondence in this regard would be entertained. Issuance of invitation to appear before the Selection Committee shall not confer any right for appointment. Appointment will be solely subject to fulfilment of all the eligibility conditions and recommendations of the Selection Committee.
22. Written Test/ Skill Test/ Trade Test/ Personal Interview of shortlisted candidates will be conducted at Head Office of Consortium situated at Indore or at Consortium's Centre/Node situated at Mumbai, Kolkata, Kalpakkam and Bhubaneswar.
23. In case of any inadvertent mistake in the process of selection, which may be detected at any stage even after the issue of offer of appointment, the Institute reserves the right to withdraw/cancel any/all communication made with the applicants.
24. No correspondence will be entertained with candidates not considered for Personal Interview/appointment. No Interim queries on schedule, result etc. will be entertained.
25. **All communications in regard with recruitment (e.g. Scrutiny result, schedule of Interview, etc.) will be made through Institute Website only. Candidates should check their email including SPAM folder regularly. 26. No TA/DA shall be paid to the candidates for attending the written test / interview.
27. The decision of the Institute in all matters related to this recruitment shall be final. No correspondence /interim inquiries will be entertained from the candidates in connection with the process of selection / interview. Any dispute with regard to the selection / recruitment process will be subject to Courts / Tribunals having jurisdiction over Indore.
